



# Acquisition of photovoltaic panel companies across China

Who owns Singapore's rooftop photovoltaic assets?

Singapore's leading energy utilities group, SP Group, announced its acquisition of up to 150 MWp of rooftop photovoltaic assets from Shanghai Unisun New Energy Co. Ltd. The first 80 MWp of distributed PV projects have been completed for a total equity consideration of approximately S\$34 million.
