Who regulates the storage of electricity in Brazil?

The storage activities will be regulated by the Brazilian Electricity Regulatory Agency (ANEEL), which will be responsible for authorizing, supervising, and defining operating rules, remuneration, and access to systems connected to the National Interconnected System (SIN) or isolated systems.

Are storage projects eligible for REIDI tax benefits?

Investment projects in storage systems will be eligible for the tax benefit set out in Law No. 11,488/2007 (the Special Regime of Incentives for Infrastructure Development - REIDI), up to a limit of BRL 1 billion per year, between 2026 and 2030.
